



Spanning the upper ground floor of an all new five-storey complex, the ICC Hearing Centre premises combine original and contemporary materials to create a bright, calm and modern working environment. The space gives direct access to a rooftop garden, with rooms overlooking landscaped patios and terrasses while the ground floor barista services offer a variety of healthy eating and drink options all day. The site also features a large, new coworking space.



### Room specifications

The ICC Hearing Centre comprises two purpose-built hearing suites and a meeting room with capacity to accommodate another hearing or meeting. Each suite features two break out rooms and one arbitrator break out room.

State-of-the-art premises designed for in-person, hybrid and virtual hearings delivering optimal efficiency, technology, confidentiality, accessibility and overall comfort.

At 120m<sup>2</sup>, our largest hearing room has capacity for 55-people and is fully equipped with audio and video features, including eight videoconferencing cameras, multiple screens and a built-in interpretation booth.

In addition, our 90m<sup>2</sup> meeting room capacity for 35 people and is fully equipped with audio and video features, including eight videoconferencing cameras, multiple screens and ability to accommodate an interpretation booth.
